We would like to extend a special welcome to our new research personnel, who have joined the Parkwood Institute Research (PIR) program over these past few months:

Renato Freire Junior- Renato is a Physiotherapist with a Master's degree in Science of Rehabilitation from Caratinga's University Centre, Minas Gerais, Brazil. He is currently pursuing a PhD in Rehabilitation Sciences and Functional Performance at the University of Sao Paulo, Brazil.
