This position involves completing a comprehensive psychosocial assessment of youth aged 16-25 with concerns related to significant mood and/or anxiety with or without substance use. The successful candidate will work within a multi-disciplinary team in an outpatient/community setting to address the specific needs of youth. This entails case management, psychotherapy, group facilitation, resource referral, conducting follow-up research, and maintaining a research database. FEMAP is a youth focused, strength based, trauma informed service with current research centring on evaluation of a novel mental health service delivery model and functional brain imaging in mood disorders. The Research Coordinator reports to the Physician Leader of FEMAP.
